



## Stabledge Sub-Flooring 50 Year Limited Warranty



### Warranty Coverage

Norbord Inc. (the manufacturer) represents and warrants that Stabledge OSB Premium sub-flooring will not delaminate, will be free of manufacturing defects and meets or exceeds product standards in the U.S. and Canada (the Product Standards) when properly used, stored, handled, installed and maintained. Stabledge OSB sub-flooring is guaranteed to never require joints to be sanded due to exposure to moisture.

### Product Standards

The Product will be manufactured in the U.S. in accordance with the Exposure 1 designation under U.S. Department of Commerce Voluntary Products Standard PS 2-04 and in Canada in Accordance with CSA Standard 0325 and PS 2-04 or in accordance with other applicable industry product standards in existence at the time of manufacture.

### Warranty Period

For a period of 50 years from the date of manufacture, this warranty is extended to the builder who purchases Stabledge, the licensed installer and initial building owner.

### Remedy

For any product not conforming to this Warranty, Norbord will pay for the repair or replacement of the panels (at wholesale cost) plus a reasonable cost of labor. Norbord may at its sole discretion cover the additional cost of removing and reinstalling finished floor coverings.

### Exclusions From The Warranty

- Damage from improper transportation, handling, installation or maintenance
- Acts of God, building design, application or construction of the structure
- Any costs related to electrical, plumbing and cabinetry
- Mold
- Minor surface flaking, edge cracking, or minor edge swelling do not qualify as delamination
- Product not installed by a licensed contractor
- Installations with exterior exposure or any space that creates an exterior environment
- Product not stored, handled, maintained and installed according to the most stringent of the appropriate building code, the engineers and/or designers specifications, or the APA Engineered Wood Construction Guide E30U

### Filing a Claim

The Purchaser will notify the Manufacturer in writing within 30 days of discovering any defects in the Product during the Warranty period. Failure to provide such notice will void the Manufacturer's obligation under this Warranty. Access to the building shall be provided for the purpose of inspection. All receipts, building permits, and installation records are to be supplied upon request.

This warranty gives you certain specific legal rights, and you may also have other rights which vary from state to state or province to province.
